The Director of the Department of Excise and Licenses, having reviewed the Recommended Decision in this matter issued on August 10, 2018 orders that:

The Recommended Decision is adopted as the Final Decision of the Department.

The following conditions shall be attached to the license:

- 1) Vape and Play's hours of operation shall be between an opening time of 9:00 a.m. seven days a week and closing times of 10:30 p.m. Sunday through Wednesday and 11:30 p.m. Thursday through Saturday.
- 2) Vape and Play shall comply with the exterior paint and signage conditions stated in its agreement with Overland Park Neighborhood Association dated April 11, 2018.

The application of the Mile High Game and Play, LLC, DBA Vape and Play for a Cannabis Consumption Permit at 1753 South Broadway, Denver, Colorado, is hereby APPROVED subject to the conditions above. This Final Decision constitutes a final agency action subject to judicial review in Denver District Court.


